Subject: Sonar FasTEST results

Good Evening Rob,

The Sonar treatment on Gages Lake is progressing well. The initial application was completed on May 1, and follow-up fasTEST samples collected on May 8 (7 days after treatment) showed concentrations of 4.7 ppb and 4.8 ppb. These levels exceed our target of 4.0 ppb, which is ideal for effective control of Eurasian Watermilfoil and Curlyleaf Pondweed.

SePRO is pleased with these results and is not recommending a bump application at this time. (Lab report attached.)


To ensure continued effectiveness, SePRO has recommended moving the next fasTEST sampling to 21 days after treatment, rather than the originally planned 30-day mark. TIGRIS will return to the lake next week to collect those samples.

Proposal for pilot composting study at the Wildwood Park District

Introduction:

- -Save Our Soil LLC, coordinating with the facilities staff of the Wildwood Park District, will manage and oversee a pilot composting project to address carp culls and lake weed
- -This pilot will run from May to November 2025, with screening and breakdown in spring 2026
- -All equipment will be provided by Save Our Soil LLC
- -Save Our Soil LLC will regularly tend to the compost (3 to 5 visits a week)
- -Facilities staff will provide woodchips and lake weed through the summer season
- -Save Our Soil LLC will assemble the compost units during the DNR carp cull, will regularly monitor temperature and odor
- -Save Our Soil LLC will provide a preliminary report in December 2025 and then a follow up addendum in spring 2026



The images above are examples of the types of units that will be assembled to compost the carp and lake weed. These units have air delivered to the feedstock through perforated pipes. The woodchips are necessary for a successful composting recipe.

Save Our Soil LLC will coordinate with the facilities staff to make sure enough woodchips are on hand.

For the carp cull, a safe estimate would be 2 units to 1, woodchips to carp ratio by volume.

For the lake weed, 1 to 1 ratio by volume.

Woodchips will be sourced from the Warren Township Hwy Dept. Should be at no cost.
